2024 Call for Nominations

Members are owners and have the right to participate in our democratic process at Swan Valley Co-op.

This Co-op is a growing local business that employs over 180 team members in Swan Valley and The Pas to serve over 5,300 active members, and many other customers throughout the region. We acquired 2 Home Centres in 2023, one in The Pas and one in Swan River. The facilities joined our Agro locations in Swan River and The Pas, as well as Food Store, Gas Bar/C-Store/Carwash, Food Store, Cardlock and Bulk petroleum locations in Swan River. In 2022, the Co-op returned \$2.4 million in profit to member owners, while focusing on sustainable growth, and providing local members with the services they want and need.

If you are a Co-op member, or know a Co-op member, who meets the requirements and has the interest, experience, and passion to support a growing organization that is locally invested and community-minded, this is the time for action.

We have opened a Call for Nominations to the Swan Valley Co-op Board of Directors until May 3, 2024 at 12:00 PM, when all nomination forms must be submitted to the Administration Office at 811 Main St. E, in Swan River.

There are **three director positions** up for election this year. Each position will be elected to serve a three-year term on the Board of Directors for Swan Valley Co-op.

Any Director elections will be held by advance voting prior to the AGM, scheduled for June 5, 2024.

All members of the Co-op are invited to attend the meeting to meet the Board, hear the annual reports and learn about the Co-op's fiscal year operations and investments in the community.

Board of Directors Criteria

Section 4 in the bylaws govern the criteria and process for electing Swan Valley Co-op's Directors

4. Directors

4.02 Personal Qualifications

No person shall become a director if that person:

- (a) is not an individual;
- (b) is less than 18 years of age;
- (c) is of unsound mind and has been so found by a court in Canada or elsewhere;
- (d) is bankrupt;
- (e) is an employee of the Cooperative, partner of an employee or immediate family member of an employee residing in the same household; or a commission operator under contract with the Cooperative;
- (f) has an account with the co-operative that is more than 60 days in arrears.

4.03 Further Qualifications

No person shall be a director unless that person or an entity of which that person is an officer, director, or member:

- (a) was a member of the co-operative at the end of the last financial year of the co-operative;
- (b) purchased goods or services, or a combination of both, from the co-operative during the last financial year of the co-operative, worth the collective amount of at least \$2000.00; and
- (c) supports the affairs of the co-operative and complies with the by-laws.

Roles and Responsibilities of Directors

To plan and oversee the business of the co-operative in accordance with the applicable legislation, regulations, bylaws and policies so that it meets the needs of its members and effectively moves the co-operative towards achieving the strategic goals and objectives developed jointly by the board and management:

- Provide strategic direction and monitor for results
 - Establish and review guiding statements
 - Develop long term business strategies
 - Monitor achievement of objectives
- Ensure effective board operations
 - Define board roles and responsibilities
 - Set board policies
 - Organize and appoint officers and committees
 - Engage in learning and performance assessment
- Conduct monitoring and oversight
 - Review and approve budgets, major plans and programs and organizational policies
 - Analyze and assess risk
- Ensure organizational performance
 - o Appoint General Manager, monitor progress and establish a succession plan
- Foster effective communications and relationships
 - Maintain ongoing, open and direct communication with members
 - Foster and maintain effective relationships with other co-operatives and community stakeholders
 - Promote awareness of the co-operative model and the Co-operative Retailing System

Code of Conduct for Directors

Directors are elected by the members of Swan Valley Co-op to represent their interests. Laws of the province of incorporation and the bylaws or rules of the co-operative define the manner in which the co-operative will conduct its affairs.

Legally, directors are expected to:

- Comply with all provincial government legislation and regulations, as well as the co-operative's bylaws, policies, procedures, etc.;
- Understand the co-operative model and principles;
- Effectively represent the interests of the members and report back to them; and
- Abide by good governance practices.

This Code of Conduct reflects the co-operative's expectations and intentions with respect to the behaviour of its directors. All directors are expected to:

- Demonstrate commitment by purchasing the goods and services provided by the co-operative to the fullest extent possible.
- Make impartial decisions that are in the interests of the co-operative as a whole, rather than for one's private interests.
- Avoid all conflicts of interest, real or perceived, that could damage the co-operative.
- Respect and abide by board decisions on all issues.
- Maintain confidentiality with regard to boardroom discussions and privileged information (including verbal information), documents and reports.
- Recognize and respect lines of authority and responsibility delegated to the General Manager (GM).
- Develop and maintain a relationship of trust and respect between the GM and the board.
- Be aware of and understand the co-operative's mission, vision, values and strategic priorities.
- Continue to develop their competencies as directors by participating in learning activities.
- Represent the co-operative and Federated Co-operative Limited (FCL) in their community by demonstrating the core values of integrity, excellence and responsibility.
- Support FCL and the Co-operative Retailing System (CRS) by actively participating and supporting the
 efforts of the federation.
